#### **Export Demurrage**

Demurrage (including equipment & storage) commences on and includes the day that the full container is gated-in at the first load port and ends on the planned arrival day of the vessel on which the container is shipped. If the container is not loaded by the carrier as intended the demurrage period will end on the planned arrival day of the vessel on which the container was booked to load. In the case of customer driven departure vessel changes, demurrage charges will continue until the planned arrival date of the new departure vessel.
