We wish to inform you that Terminal Handling Charges in Brazil will be updated for all Hamburg Süd and Aliança shipments, according to below table. In view of the higher costs attributed to the shipment of Dangerous Goods (IMO/DG) in certain ports, a special THC tariff will be set:
